Nonaffiliates	<ul> <li>Companies not related by common ownership and control.</li> <li>They can be financial or nonfinancial companies.</li> <li>We do not share with nonaffiliates so that they can market to you.</li> </ul>	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or service to you. <i>We do not jointly market.</i>
